# CITY OF LAGRANGE, GEORGIA REGULAR MEETING OF THE MAYOR AND COUNCIL

#### March 22, 2022

The meeting was called to order by Mayor Thornton, the invocation was given by Rev. Fred Stanley, and Mayor Thornton led the Pledge of Allegiance to the Flag.

On a motion by Mr. Gaskin seconded by Mr. Arrington, Council unanimously approved the minutes of the regular Council meeting held on March 8, 2022.

A public hearing was held to receive comments on a request to rezone property located at 304 Broad Street from TN-MX to DT-MX. No comments were received and Council heard the first reading of the following ordinance:

#### AN ORDINANCE

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF LAGRANGE TO AMEND THE CODE OF THE CITY; TO AMEND THE ZONING MAP AND ORDINANCES OF THE CITY SO AS TO CLASSIFY THE USE ZONE OF REAL ESTATE TO BE ANNEXED INTO THE CITY LOCATED ON LAFAYETTE PARKWAY AND OWNED BY B'S MEAT MARKET, LLC; TO REPEAL CONFLICTING ORDINANCES; TO FIX AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

Tabitha Coverson, Executive Director of Communities in Schools, updated the Council on the progress from this past year. Ms. Coverson thanked the Council for their continued support. The Council praised Ms. Coverson's work in the community and thanked her for her service.

Holly Winner, Executive Director of the American Red Cross, updated the Council on how the Red Cross has assisted in our community this past year. Mayor Thornton thanked Ms. Winner for the update and for their presence in our community.

Phil Nations, Candidate for the Troup County Commission Chair in the upcoming election, introduced himself to the Council. Mr. Nations told of his background in the community, and stated he was looking forward to working with the Council and the city as a whole. Mayor Thornton thanked Mr. Nations for coming.

Mr. Kostial presented to the Council a recommendation from the Board of Planning and Zoning Appeals regarding UDO text amendment for minimum distance requirements. On a motion by Mr. Arrington seconded by Mr. Mitchell, Council voted unanimously not to amend the current text for minimum distance requirements.

Mr. Kostial presented to the Council a recommendation from the Board of Planning and Zoning Appeals regarding UDO text amendment for industrial parking ratio requirements. On a motion by Mr. Edmondson seconded by Mr. Mitchell, Council voted to call for a public hearing to be held on April 12, 2022 at 5:30 p.m.

Mr. Gaskin expressed his concern for continued violence in the community. He would like to see more love in LaGrange.

Ms. Kelsey presented to the Council information regarding the City of LaGrange Tax Allocation District (TAD) Number One – Commercial Gateway. She explained that the TAD was established in 2012 and there has been no development on this project. On a motion by Mr. Gaskin seconded by Mr. Edmondson, Council voted unanimously to approve a Resolution to terminate the Tax Allocation District Number One. A copy of the Resolution is on file in the City Manager's Office.

Ms. Kelsey also presented information to the Council regarding the City of LaGrange Tax Allocation District (TAD) Number Three – Veterans Village. She explained that this TAD was also established in 2012 and there has been no development on this project. On a motion by Mr. Edmondson seconded by Mr. Gaskin, Council voted unanimously to approve a Resolution to terminate Tax Allocation District Number Three. A copy of the Resolution is on file in the City Manager's Office.

On a motion by Mr. Edmondson seconded by Mr. Arrington, Council voted unanimously to approve the following ordinance:

#### AN ORDINANCE

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF LAGRANGE TO AMEND THE CODE OF THE CITY; TO MODIFY THE LAWFUL SPEED LIMITS ON CERTAIN CITY STREETS TO CONFORM TO DEPARTMENT OF TRANSPORTATION RECOMMENDATIONS; TO REPEAL CONFLICTING ORDINANCES; TO FIX AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

THE MAYOR AND COUNCIL OF THE CITY OF LAGRANGE, GEORGIA, HEREBY ORDAIN AS FOLLOWS:

# **SECTION 1**:

That Section 10-20-4 of the Code of the City of LaGrange be amended by deleting therefrom subparagraph (a)(4)b., in its entirety. The remainder of the subparagraphs within Section 10-20-4(a)(4) shall be alphabetically re-designated appropriately.

# **SECTION 2**:

That subsection (b) of Section 10-20-4 of the Code of the City of LaGrange be amended by deleting therefrom the entry entitled "Cannon Street School Zone," in its entirety.

# **SECTION 3**:

That subsection (b) of Section 10-20-4 of the Code of the City of LaGrange be amended by inserting therein, in proper alphabetical order, a new entry to be entitled "Tom Hall Parkway," to read as follows:

"*Tom Hall Parkway*, from its intersection with Hamilton Road/S.R. 1 to its intersection with S.R. 219, 45 miles per hour."

# **SECTION 4**:

That subsection (b) of Section 10-20-4 of the Code of the City of LaGrange be amended by deleting the entry entitled "Greenville Street," in its entirety.

# **SECTION 5**:

That subsection (b) of Section 10-20-4 of the Code of the City of LaGrange be amended by inserting therein, in proper alphabetical order, an entry to be entitled "Hills and Dales Farm Road," to read as follows:

"Hills and Dales Farm Road in its entirety, 40 miles per hour."

# **SECTION 6**:

That subsection (a)(2) of Section 10-20-4 of the Code of the City of LaGrange be amended by inserting therein a new subparagraph h., to read as follows:

"h. S.R. 14 Spur from a point 680 feet south of Lukken Industrial Drive East to a point 380 feet north of Lukken Industrial Drive East, a distance of 0.26 miles, 45 miles per hour, school days only, from 7:00 a.m. to 8:00 a.m. and 2:00 p.m. to 3:00 p.m."

# **SECTION 7**:

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

# **SECTION 8**:

This Ordinance after adoption by the Council and upon approval by the Mayor shall become effective immediately.
